5. Annual rent will be enhanced by 10% calculated over the value of the preceding year for the 2nd and 3rd year.

7. Bathing & Washing of human and cattle and passes of stagnant water in the ponds will continue as usual. No objection / obstruction will be entertained. Water of the Kaldighi Water Body may be utilized for Irrigation purpose and responsibility in respect of electric connection will be borne by lessee himself.

8. Interested bidders may attend a pre-bid meeting to be held on 18.03.2022 at 12.00 noon at undersigned office.
