3. The E-auction Committee of Dakshin Dinajpur Zilla Parishad will have sole discretion to decide the eligibility of the bidders on the basis of his submitted documents and reserves the right to refuse any explanation to the bidder without assigning any reason thereof and the decision of Zilla Parishad authority shall be final and binding in this respect. Original copy of the payment documents as

participation charge and EMD must be deposited to the Office of the undersigned from 18.03.2022 to 19.03.2022 during office hours.

4. The Highest Bidder will have to deposit all the lease money at Zilla Parishad Office of that particular year at once and no installment basis payment will be allowed.

5. Annual rent will be enhanced by 10% calculated over the value of the preceding year for the 2<sup>nd</sup> and 3<sup>rd</sup> year.

6. All papers will be verified with original papers as and when required.

7. Bathing & Washing of human and cattle and passes of stagnant water in the ponds will continue as usual. No objection / obstruction will be entertained. Water of the Kaldighi Water Body may be utilized for Irrigation purpose and responsibility in respect of electric connection will be borne by lessee himself.

8. Interested bidders may attend a pre-bid meeting to be held on 18.03.2022 at 12.00 noon at undersigned office.


9. **Participation Charge and EMD Payment procedure::**

**Intending bidders have to submit their bid on-line through e-auction portal of Zilla Parishad of P & RD Deptt <https://eauction.gov.in>. The participation charge and the earnest money should be deposited through NEFT or RIGS (as the case may be) through savings bank account no : 31194254645 (SBI, Balurghat) in favour of DDZP. The scanned colour copy of the payment document as participation charge or earnest money (as the case may be) must be uploaded in the appropriate folder.**

10. SD/EMD of unsuccessful bidders will be refunded after one month completion of e-auction procedure.

11. Highest bidder will have to deposit the entire amount within a week after receiving the offer letter from this office end. Otherwise, 2<sup>nd</sup> position bidder will be entertained and EMD of the defaulting bidder will be forfeited.

12. The bidders at their own responsibility and risk is encouraged to visit and examine the site of works and its surrounding and obtain all information that may be necessary for preparing the bid and entering into a contract for the work mentioned in the Notice. The costs of visiting the site shall be at the bidders own expense.


