SCOPE OF WORK-

Title of proposed projects: Consultancy Service in connection preparation of DPR. Scope of work and other details are available in this office during working hours **10.30 AM to 4.30 PM** on working days. The DPR is required to be prepared following the general guidelines given below:

1. The DPR will consist of detailed survey, soil investigation report, detailed drawing, detailed estimate, C.D. work, drainage work, protection work also including all photographs.

2. Topographical survey :

- a) All level of work and necessary drawing.
- b) Plot all the permanent structures like building, hutment, electric poles, any other poles or trees etc falling within the proposed area.
- 3. Necessary soil and water investigation works as per the existing codes and provisions to ascertain the approach for the structural design, foundation design and other design for physical infrastructure. Investigation report duly signed by competent authority in this regards to be submitted along with DPR.
- 4. Intending bidders have to submit their bid on-line through e-procurement(two cover system) portal of Zilla Parishad of P & RD Deptt <u>www.wbtenders.gov.in</u>. The participation charge and the earnest money should be deposited as follows-

EMD payment procedure-

- a) Payment by Net Banking(any listed bank) through ICICI Bank Payment Gateway,
 - i. On selection of net banking as the payment mode, the bidder will be directed to ICICI Bank payment Gateway webpage(along with a string containing a Unique ID) where he/she will select the Bank through which he/she wants to do the EMD on-line transition.
 - ii. Bidder will make the payment after entering his Unique ID and password of the bank to process the transaction.
 - iii. Bidder will receive a confirmation message regarding success/failure of the transaction.
 - iv. If the transaction is successful, the amount paid by the bidder will get credited in the respective pooling account of the State Government maintained with the Local point branch of ICICI bank at RN Mukherjee Road, Kolkata for collection of EMD against unique codes for identification of the tendering authority.
 - v. IF the transaction is failure, the bidder will again try for payment by going back to the first step.

Payment through RTGS/NEFT-

- On selection of RTGS/NEFT as the payment mode, the e-procurement portal will show a pre-filled challan having the details to process RTGS/NEFT transaction.
- ii. The bidder will print the challan and use the pre-filled information to make RTGS/NEFT payment using his/her own Bank account.
- iii. Once payment is made, the bank would provide an "**UTR remittance number**" for successful transaction with which the bidder will come back to the e-procurement portal after expiry of 2 to 3 bank working days to enable the NEFT/RTGS process to complete, in order to verify the payment made and continue with his/her bidding process.
- iv. If verification is successful, the fund get credited to the respective pooling account of the State Government maintained with the local point branch of ICICI bank at RN Mukherjee Road, Kolkata for collection of EMD.
- v. Hereafter, then bidder will go to e-procurement portal for final e-submission of his/her bid within pre assigned last date of submission of e-tender.
- vi. If the payment verification is unsuccessful, the amount will be returned automatically by the system to the bidder's account.

5. The Earnest Money may be forfeited

- a) If the Bidder withdraws the Bid after Bid opening (technical bid) during the period of Bid validity.
- b) In the case of a successful Bidder, if the Bidder fails within the specified time limit to-
- i) Sign the Agreement and/or
- ii) Furnish the required Performance Security.

- 6. The consultant shall have to be quoted their rate on percentage rate basis with respect to it's Sanctioned cost for preparation of DPR including all work as mentioned in Sl No. 01 & 02. Submission of DPR in 2 parts (Vol-I & II) in six bound copies each and one soft copy as per detailed scope of work annexed with the bid documents. Four copies of BOQ/or more (if required) are to be submitted after sanction of the estimate by Vetting Cell of P&RD. Deptt. Govt. of West Bengal. The DPR is to be prepared to satisfy the Technical Sanctioning Authority . If required the DPR may have to be modified/ revised etc. as per instructions of the Vetting Cell, P&RD Department. The rate should be inclusive of all types of taxes, tolls, cess, service tax etc. payable to the State Govt. of West Bengal.
- 7. The Earnest Money deposited shall be converted into part of Security Deposit. S.D. will be refunded after acceptance of DPR by the Department.

- 11. The bidder must have completed minimum 01(one) no. DPR of roads
- 12. DPR of the roads will be executed by the lowest bidder as finally selected by the Zilla Parishad Authority.
- 13. Payment will be made after vetting from the P&RD Department, Kolkata and also fund placed by the Funding Authority.
- 14. The successful bidder will be engaged for **01(one) year** with same quotated rate from the issue of work order.

Part-1: This shall be named as Technical Bid and shall comprise of -

- 1. Undertaking that the Bid shall remain valid for 180 days from the date of opening of Financial Bid.
