
1. Documents to be uploaded by bidders: -

The E-auction Committee of Dakshin Dinajpur Zilla Parishad will have sole discretion to decide the eligibility of the bidders on the basis of his submitted documents and evaluation and reserves the right to refuse any explanation to the bidder without assigning any reason thereof and the decision of Zilla Parishad authority shall be final and binding in this respect. 
