- 6. Self attested copies of Pan card, Professional Tax Clearance Certificate, GST Registration Certificate. Registered Engineering Co-Operative Society and Registered Labour Co-Operatives must upload the Bye-Laws, and other papers and submit the same will full address of their authorized persons to sign the tender documents along with technical Bid papers.
