SCOPE OF WORK-

Title of proposed projects: Consultancy Service in connection preparation of DPR. Scope of work and other details are available in this office during working hours **10.30 AM to 4.30 PM** on working days. The DPR is required to be

prepared following the general guidelines given below:

- 1. The DPR will consist of detailed survey, soil investigation report, detailed drawing, detailed estimate, C.D. work, drainage work, protection work also including all photographs.
- 2. Topographical survey :
 - a) All level of work and necessary drawing.
 - b) Plot all the permanent structures like building, hutment, electric poles, any other poles or trees etc falling within the proposed area.
- 3. Necessary soil and water investigation works as per the existing codes and provisions to ascertain the approach for the structural design, foundation design and other design for physical infrastructure. Investigation report duly signed by competent authority in this regards to be submitted along with DPR.
- Intending bidders have to submit their bid on-line through e-procurement(two cover system) portal of Zilla Parishad of P & RD Deptt <u>www.wbtenders.gov.in</u>. The participation charge and the earnest money should be deposited as follows-<u>EMD payment procedure-</u>

If the transaction is successful, the amount paid by the bidder will get credited in the respective pooling account of the State Government maintained with the Local point branch of ICICI bank at RN Mukherjee Road, Kolkata for collection of EMD against unique codes for identification of the tendering authority.
 - v. IF the transaction is failure, the bidder will again try for payment by going back to the first step.

Payment through RTGS/NEFT-

- On selection of RTGS/NEFT as the payment mode, the e-procurement portal will show a pre-filled challan i. having the details to process RTGS/NEFT transaction.
 - The bidder will print the challan and use the pre-filled information to make RTGS/NEFT payment using ii. his/her own Bank account.
 - iii. Submission of DPR in 2 parts (Vol-I & II) in six bound copies each and one soft copy as per detailed scope of work annexed with the bid documents. Four copies of BOQ/or more (if required) are to be submitted after sanction of the estimate by Vetting Cell of P&RD. Deptt. Govt. of West Bengal. The DPR is to be prepared to satisfy the Technical Sanctioning Authority . If required the DPR may have to be modified/ revised etc. as per instructions of the Vetting Cell, P&RD Department.
