The financial bid document of the technically qualified tenderers will be opened only after evaluation and selection of qualified tenderers, the date and time of which will be circulated later on. If the dates are changed due to unavoidable circumstances intimation will be given in website and office notice board. No individual intimation will be issued in this connection.

#### A. Eligibility Criteria for Participation in tender & Information to Bidders.

- i) Intending tenderers should produce credential of a similar nature of completed work of the minimum value of 40%(for 1<sup>st</sup> call), 30% (for 2<sup>nd</sup> call) and 20%(for 3<sup>rd</sup> call) of the estimated amount put to tender 5(five) years prior to the date of issue of the tender notice or
- ii) Intending tenderers should produce credential of 2(two) similar nature of completed work each of the minimum value of 30% (for 1<sup>st</sup> call), 25%(for 2<sup>nd</sup> call) and 20%(for 3<sup>rd</sup> call) of the estimated amount put to tender during 5(five) years prior to the date of issue of the tender notice or
- iii) Intending tenderers should produce credential of one single running work of similar nature which has been completed to the extent of 80%(for 1<sup>st</sup> call), 75%(for 2<sup>nd</sup> call) and 70%(for 3<sup>rd</sup> call) of more and value of which is not less than the desire value at (i) above
- 2. During scrutiny of Technical Bid/Tender documents, if it is found that any information is incorrect the technical bid/tender documents will be rejected without assigning any reason thereof. The Tender Committee of Dakshin Dinajpur Zilla Parishad will have sole discretion to decide the eligibility of the Contractors on the basis of his

3. Intending bidders have to submit their bid on-line through e-procurement (two cover system) portal of P & RD Deptt., Govt. of West Bengal (<u>www.wbtenders.gov.in</u>). The participation charge and the earnest money should be deposited as follows-

# EMD payment procedure-

a) Payment by Net Banking (any listed bank) through ICICI Bank Payment Gateway

- i. On selection of net banking as the payment mode, the bidder will be directed to ICICI Bank payment Gateway webpage (along with a string containing a Unique ID) where he/she will select the Bank through which he/she wants to do the EMD on-line transition.
- ii. Bidder will make the payment after entering his Unique ID and password of the bank to process the transaction.
- iii.Bidder will receive a confirmation message regarding success/failure of the transaction.
- iv. If the transaction is successful, the amount paid by the bidder will get credited in the respective pooling account of the State Government maintained with the Local point branch of ICICI bank at RN Mukherjee Road, Kolkata for collection of EMD against unique codes for identification of the tendering authority.
- v. IF the transaction is failure, the bidder will again try for payment by going back to the first step.

### b) Payment through RTGS/NEFT

On selection of RTGS/NEFT as the payment mode, the e-procurement portal will show a pre-filled challan having the details to process RTGS/NEFT transaction.

- i. The bidder will print the challan and use the pre-filled information to make RTGS/NEFT payment using his/her own Bank account.
- ii. Once payment is made, the bank would provide an "UTR remittance number" for successful transaction with which the bidder will come back to the e-procurement portal after expiry of 2 to 3 bank working days to enable the NEFT/RTGS process to complete, in order to verify the payment made and continue with his/her bidding process.
- iii. If verification is successful, the fund gets credited to the respective pooling account of the State Government maintained with the local point branch of ICICI bank at RN Mukherjee Road, Kolkata for collection of EMD.
- iv. Hereafter, then bidder will go to e-procurement portal for final e-submission of his/her bid within pre assigned last date of submission of e-tender.
- v. If the payment verification is unsuccessful, the amount will be returned automatically by the system to the bidder's account.

## The Earnest Money may be forfeited

- a. If the Bidder withdraws the Bid after Bid opening (technical bid) during the period of Bid validity.
- b. In the case of a successful Bidder, if the Bidder fails within the specified time limit to-
